Summary

At The Coca-Cola Company, our engagement in the political process is rooted in a commitment to supporting public policies that advance our business goals, reflect our values, and contribute to the communities we serve.

Integrity, transparency, and nonpartisanship are the guiding principles that underpin our approach to political engagement. We engage with policymakers and industry groups to help share thoughtful, evidence-based policy solutions, regardless of political affiliation.

On a semi-annual basis, we publicly disclose direct political contributions as well as indirect payments made through trade associations and social welfare organizations that may be used for lobbying purposes. These payments do not imply the company's full alignment with all the policy positions of a candidate or organization, nor does it suggest future support. Each disbursement is evaluated individually and periodically in compliance with the U.S. Political Engagement Policy.

The company's participation in the political and lobbying processes is conducted in accordance with the principles of the Code of Business Conduct and strict compliance with applicable laws and regulations.
